**A. Committee Members**

⇒ **Barnaby:** Responded to Ashley that their funding is specifically for ASI programs. The groups who come to Finance are student organizations which is a different pot of money. It could happen where we could come to this group for a special project that is not budgeted for.

**B. Advisors**

**Barnaby:** Last BOD meeting you all recommended to approve the audit report, and it was a clean audit report with no findings. He also stated that Gus and the marketing team are doing some projects for the university departments, and we are getting paid so this income that was not budgeted for and sometime in the future they would have to decide how to use those funds this year.

**Fabi:** The student organization recognition period closed on Monday and there is about 140 student organizations new and returning which is the most had since the pandemic. The lists and contacts will be sent over; whatever is shown on the Nests are the active RSOs.

**Carlos:** It is good that we are hearing about the new updates to as most of our building are old. He also said that one of the big pressures hitting our university is that the governor has deferred the compact. The CSU cut went from 8% to 3%. There is some big impacts that have already been on the grant side around \$15 million of grants have been canceled or delayed or pulled back. All universities are looking out for an impact and mostly by the health branch.


