A. U.C.C.O Funding Policy 224—The committee will review and vote on the changes made to the Funding Policy.

- Jaime: The meetings have doubled from last year. A lot of work, we have our academics...
- Magali: Anyone else have a concern or comment?
- Guillermo: Every quarter is like 3 meetings
- Jaime: Sending new members to workshops—will have trouble getting to meetings by spring with all events
- Peter: Concern of getting to tier 3. How is it going to work every quarter to have to start over?
- Magali: So we don't restart the tier system...extend the tier system for the entire year. It might seem repetitive but the more information the better
- Peter: likes the idea of maintain the tier. And idea to maintain we go to UCCO meetings
- Magali: There are 4 UCCO meeting this quarter
- Peter: how many meetings can a club skip in order to restart or bump down from the tier after you hit tier 3?
- Magali: Keep a set amount of UCCO meetings tier 1—1 UCCO meeting per quarter
- Jaime: if you want funding attendance to all UCCO meetings are mandatory
- Peter: easiest stuff shouldn't be per quarter but per academic year
- Jaime: clubs shouldn't be able to get flyers with tier 1
- Marcus: Get to Tier 3 by spring quarter...Look at UCCO meetings
- Magali: I like that the total amount of meetings are UCCO
- Peter: I don't see why a club who has been attending regularly
- Magali: So you want to maintain your tier for more than one year?
- Peter: Yes
- Magali: Not possible to maintain for the next year. What can we do is extend the tier system but add on more UCCO meetings and open up more ASI meetings that you can attend (any ASI committee)
- Magali: Tier 1-1 meeting. Tier 2-3 meetings. Tier 3-6 minutes throughout the year

- Magali: No maybe til mid winter
- Jaime: every meeting will restart and nothing will get done. Last year ...
- Magali: That is the reason why I like the last tier system
- Jaime: None of everything got done
- Marcus: discussions like this has been happening before
- Peter: compromise between option A and B. Extra meetings 1 st quarter and cut off once you get to the 3rd tier extra meetings
- Magali: If I keep attending UCCO's mandatory stuff. Only keep the UCCO next quarter?
- Marcus: no extra meetings. Funding workshop is mandatory
- Magali: you can send anyone else to represent your club but funding requests has to be signed by a recognized officer
- Magali: Who wants to extend the tier system for the year?
- Peter: It works I guess
- Magali: We are going to take a vote. Tier 1-1 UCCO, 1 ASI committee meeting. Tier 2-3 UCCO, 2 ASI committee, Tier 3-6 UCCO, 3 ASI committee. I will provide a sign in sheet for CCOE and all committee meetings. UCCO has a \$3000 budget for the year, but whatever is left over does not roll over to the next academic year
- Marcus: What happens when we run out? There is always savings that can be rolled to UCCO if we see the need needed
- Magali: \$450 limit, I was thinking of \$500
- Jaime, Peter, etc: I agree with \$450
- Magali: Lets take it to a vote
