a. 6 & 6 Budget- The Board will discuss 6 & 6 budget presented by the Vice President of Finance

- i. **Diana Chavez:** Josue isn't here today so Dena will be explaining the budget.
- ii. **Dena Florez:** Finance will be taking action on the budget this Friday so if there is something you want to say or do please come. *6 & 6 budget as explained and presented by Dena Florez.*
- iii. **Ledi Loot:** The auditing company is the same as the CSU correct?
- iv. **Dena Florez:** No, we invite different companies, but we happen to choose the same ones as the CSU this time around.
- v. **Ledi Loot:** So, they are leaving what happened to that?
- vi. **Dena Florez:** It is good business practice to change you auditor every three years. *Dena continues to explain the 6 & 6 budget.* There has been talk to change food pantry to housing or basic needs, but we serve students. Any questions?

b. Resolution on Reforming Campus Police- The Board will discuss the resolution on reforming campus police.

- v. **Diana Chavez:** We are actually currently trying to do that because BSU is trying to get some students to try and talk to me because he knows students who has experiences as well.
- vi. **Ledi Loot:** Yes, I think this will be stronger if it is a collaboration of many students.
- vii. **Dena Florez:** This comes about because of what we have been hearing from the students right? So, student voices are included.
- viii. **Diana Chavez:** Yes, but I think what Ledi is trying to say is that we need more narrative on the unfair treatment part. Because overall we are trying to bring up the fact that our campus police have treated students unfairly
- ix. **Ledi Loot:** Yes, I am trying to get something from everyone, so it won't seem like it is leaning to one-side. Have you talked to the Latin American clubs?
- x. **Diana Chavez:** I haven't, that is a good idea. I still have a week to revise before it goes up to action.
- xi. **Jocelyn Vargas:** I think maybe changing the language to something the shows historically marginalized groups to be inclusive of everyone. Also, Instead of METCHA maybe SQE because they have member of every

organization. I would also recommend getting student feedback on a form because it can be traumatic to recall those experiences.
